### F1 Typical Inductance vs. Current Characteristics:



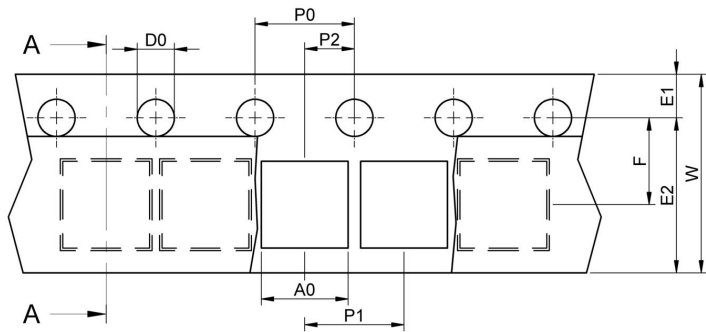
### F2 Typical Impedance Characteristics:



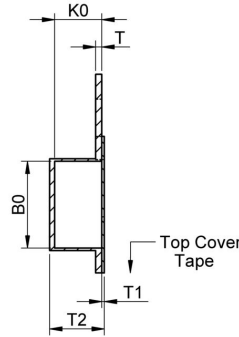
